Archery – Right to the Point

Egad! Odds bodkins! Sound the clarion! Our upcoming archery event, to be held Saturday (May 14) at "Arts & Arrows" will be historic in breadth and scope. And, yet, strangely intriguing.

The scenario: We're in a small village in the Austrian-Swiss Alps. It is the year 1308, and you're invited to take part in our special competition. It should be fun. It will be challenging. At day's end, an overall tournament champion will be declared, as will our first "Archery Champion of Glenn Linn" (must be a gentle of the shire).

The Basics:

- The tournament will be shot on Saturday only. We will shoot it once in the morning and once in the afternoon. The highest score from each portion will count toward the over-all tournament and shire championships, whether shot in the morning or afternoon. A tie in the scores for overall tournament champion and/or shire champion will be settled by a shoot at a medieval traditional target.
- Practice shooting alongside the Royal Round field only will be offered prior to the morning and afternoon tournament shoots. A few loaner bows and arrows will be available, and basic lessons will be offered at the practice field.

All shooting will be at the discretion of the archery marshall-in-charge.

Note: No actual fish, human heads, animals, poachers, villagers, or flesh-eating dragons will be shot. All other descriptions, terms, and tournament criteria are subject to change.

The tournament:

The "Royal Round." We humbly extend you an invitation to shoot a standard "Royal Round."

Fishin' A Round. For a feast of a certain scale. It's like "shooting fish in a barrel."

Our "William Tell." Shoot the apple off your kid's head or you will be executed. You may draw two arrows – one for the apple, and, if you miss, the other at the head of the Austrian overseer. [For your convenience, we supply the kid and the overseer. Some executions may be deferred.]:

The "King's Woods." We will hunt "game." Look lively...we shoot poachers, not villagers.

The "Blinded Archer." [For experienced archers only who can easily nock and shoot an arrow while blindfolded.] Here, a scavenging dragon has landed, seeking it's own "feast." When you prepare to draw your first arrow, you are blinded [via our specially clouded glasses] by it's vapid breath. Be very scared. Listen...it's heartbeat...it's voice...it speaks...shoot!

Be sure to spread the word: "Arts & Arrows." Come for the whole weekend, share the camaraderie, embrace the challenge. I am confident you will shoot well.



Interview with Lord Uust MacSkelton, Knight Marshal

What's your modern name? Josh Skelton

What's your SCA name? Uust MacSkelton

How did you get interested, or who introduced you to the SCA? I always had an interest ,(as a child i had family who played) but for most of my life no time. I finally ended up at the Water Walk demonstration and met Asgar and Frigga, and the rest fell into place from there).

How long after joining did you create your persona? Not very long, perhaps 6 months or so.

How long did it take to gather all the information on the persona you chose? Thanks to the magic of the interwebs only a few days.

Was it difficult to choose one period for your persona to be in? Yes and no. I simply picked my family's historic background, so it was was easy to home in on the people, but I was torn between the 14th century Scots, and the 7th century Picts. The Picts won out because the details around them were murkier and it was during the time of the Diaspora so it gave me lots of wiggle room for story and armor and such.

Did you find resources within the Shire that helped, and what were they? Yes, the Shirefolk were very helpful in pointing me towards the right websites to choose my name and offered help on every turn in choosing name and persona.

I bear that at events, you get very into character. Is there any particular reason why? Why not? We are out to have a good time in the SCA and have adventures that most people only read about in books or see on T.V.. Also there's alcohol involved and in the words of the cowboy who ran off the porch and jumped in a cactus when questioned why he did it, "It seemed like a good idea at the time!"

Why do you think that people stay in our Shire? Because the shire is full of good folks who support each other through everyday affairs and in times of crisis. Also the bacon)

These are now the release forms needed— one for creative work (such as articles and artwork), a second for photography and a third for photography models. The creative work form has some new additions that I hope you will find helpful. The photographer and model release forms are a new requirement but if the contributor chooses, both may be completed *only once* for all current and future submissions. Additionally (again, if the contributor chooses) they can allow their submission to be printed in any media including print, web or electronic, so these forms give much more leeway for sharing text and images not only between web ministers and chroniclers, but also between branches.

These forms must be in used by every Society publication and web site by JANUARY 1, 2011, with the exception of one: The Compleat Anachronist (they will have different versions of the form). Any and all earlier versions of release forms must be replaced. The forms cannot be modified, either by addition or deletion, with one exception: adding the name of the specific publication and/or web site. As you will see in the notes below, I come back to this point again and again, but legal was very specific on this detail.

Chroniclers and webministers can receive the completed and signed forms electronically. The form is supplied both as a regular PDF and as a fillable PDF. I will also to be able to supply a hard copy of the completed form upon request, so print copies will be available for successors.

NOTES on the CREATIVE WORK COPYRIGHT ASSIGNMENT/GRANT OF USE FORM

1. For text, the contributor can check a box to indicate "you can edit my work". This feature is already in place in some kingdoms, with the accompanying requirement that the editor's name be published as well. The accompanying requirement is not part of the form, and it cannot be added to the form, but you can make it part of your local publication policy, if you would like.

2. This form cannot be used to grant permission to print an individual's personal information. Within the bounds of Society and kingdom policies, you can receive this information via e-mail, set up a separate permission form, etc., but that permission cannot be added to this form.

3. "Publish my work electronically" is intended for publications that are being distributed solely via e-mail, on CD, or through similar media.

4. On "publish the Work on a SCA web site for ______", a most common answer would be "the Kingdom of Provincia", but this can also be completed as "the Barony of Magnificentia's Arts & Sciences". (This is to avoid using web addresses: Magnificentia will probably still have an Arts & Sciences page in 10 years, but the address could well have changed.)

5. The forms are part of the office and cannot be assigned to an individual office-holder. An individual office-holder's name cannot be added to the form.

6. If the individual contributor wants to add an "expiration date" (i.e., wants to say "you can publish this once before January 1, 2015" – or whatever date applies) they can do so, but otherwise (I think you have the refrain by now) it cannot be added to the form.

NOTES on the PHOTOGRAPH GRANT OF USE FORM

1. If a photographer wants to allow publication of any photo they submit, they can check the box under "Perpetual Grants of Use".

2. The statement "I agree that all of the grants of use I have given above include the right of the SCA to publish my photo in any reprint of a publication including electronic media" is designed for publications that come out in more than one format (i.e. a local newsletter that is both traditionally mailed and e-mailed).

NOTES on the MODEL RELEASE FORM

1. Most members are happy to have their photograph used, so I conjecture that the majority of the contributors will check option 1.

2. The model release form is required for all identifiable photo subjects, including royalty, so you may want to consider having the forms available at/before Crown Tourney.

NOTE on EXISTING WEB SITE IMAGES

The Board of Directors has voted to leave existing images on web sites as they are, but asks that web ministers make the attempt to get releases on as many images as is feasible. All future submissions need to have the completed release forms. Additionally, any time someone asks for an image to be removed the web minister needs to acknowledge that it was removed, let the requestor know what day it was removed and keep that correspondence as part of the office.
